### What is SOAR?

SSI/SSDI, Outreach, Access, and Recovery (SOAR) is a nationally recognized best practice model for helping people apply for Social Security disability benefits at the initial and reconsideration levels.

### The Benefits of SOAR Training

SOAR approval rates in Colorado are 65% on average, which is significantly higher than the 35% approval rates for unassisted people at the initial level and drops to 10-15% for people experiencing homelessness. In addition, knowing the application process helps individuals obtain benefits faster, maximize their back pay and monthly benefits, and helps individuals understand and connect with other vital supports, such as ABLE accounts, benefits counselors, employment specialists, family and estate planning services, representative payees, and more!

### Resources Provided

Trainees will receive slides, exercises, guides, workflow models, SSA forms, and are eligible to join every other week TA calls to help further their growth.

### Candidates for this Training

Anyone assisting in or preparing for the SSA disability application process, including individuals applying for SSI/SSDI, families of individuals with disabilities, clinicians, case managers, advocates, and staff who provide services to individuals in need of accessing disability benefits. SOAR training benefits individuals most if they plan to assist with multiple Social Security applications. If you only expect to provide advice or work on one application with a friend or family member, then you may wish to consider our disability webinar series.
